HIGHLIGHTS OF THE ANNUAL MEETING

2007 BUDGET AND LEVY

The proposed budget and levy for 2007 was reviewed and the \$260,000.00 levy for 2007 was voted on and accepted.

- 1. Authorization of an Interim Use Study for multi-family use.
- 2. Established erosion control and storm water management requirements for land disturbances.
- 3. North Cannon River Watershed Management Ordinance.
