I would also like to welcome two new members to the Board; Mark Molitor and Drea Doffing who were elected this past March. This past election there was also a question on the ballot on whether the clerk's position would be elected or appointed by the Board. The votes came back to have the clerk an elected position. Road Report

Spring road projects have begun again. Several sections of ditch were cleaned in April to maintain positive drainage. Landowners are reminded that planting of crops in the right of way will not be tolerated.

Dust proofing will begin in mid-May and progress as placement of gravel continues. Dust proofing will be placed in front of houses in close proximity to township roads. The first 300' will be placed for free to residents that qualify. Additional footage may be purchased at a rate of \$45.00 per hundred feet.

The gravel budget for 2009 was increased by almost double, but this was accomplished by use of funds received by Minnesota Pipeline Co. for road reconstruction.

We are presently working on a new right of way ordinance to make sure all future public utility projects through the township are dealt with in a way to alleviate road issues.
